This warranty shall be in effect only when the product has been applied pursuant to manufacturer's specifications and the highest industry standards and by a certified applicator. This warranty is extended to the original purchaser of this product. Poly-Granite shall have no obligation to contribute or participate in the labor costs necessary to effect repairs. THIS WARRANTY DOES NOT COVER DAMAGES RESULTING FROM FIRE, SETTLING, MAJOR BUILDING MOVEMENT, FAULTY PLUMBING LEAKS, LEAKS FROM OTHER MECHANICAL PROTUSIONS, LEAKS FROM INSIDE THE WALL, WICKING FROM THE FOUNDATIONS, MOISTURE VAPOR DRIVE, UNSOUND SUBSTRATES, ACTS OF GOD (I.E. TERMITES, HURRICANES, TORNADOS OR EARTHQUAKE). Warranty applies only to the surface it is applied to.

This warranty is issued in lieu of all other guarantees or warranties. The terms of this warranty is limited to the express warranties contained herein and are not subject modifications.
